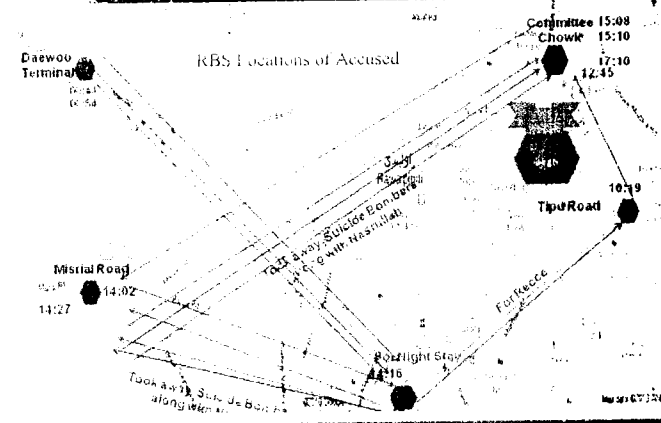

BB's Armored Toyota Land Cruiser after the Blast



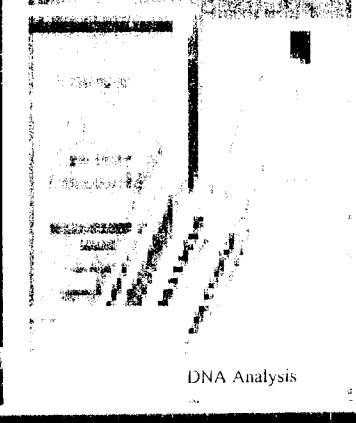
Call Record Analysis

**Gist of FIR**

1. On 27-12-2007 at about 5.11 p.m, Mohtarma Benazir Bhutto after addressing the public gathering boarded on vehicle No.BF/7772 Land Cruiser alongwith his party leaders and left the Liaquat Bagh, Rawalpindi. When her vehicle reached at Liaquat road outside the Liaquat Hall gate, she appeared from the sun roof (Escape Hatch) of her vehicle to respond to the slogans of the party workers. An unknown accused present near her vehicle fired at her with pistol and blown himself. Mohtarma Benazir Bhutto got serious injuries. She was immediately shifted to the Rawalpindi General Hospital (RGH) where she succumbed to her injuries. Legal heirs did not allow post mortem of her dead body. However, according to the Medical Report, her death occurred due to "open head injury with depressed skull fracture, leading to cardiopulmonary arrest". The wound was measuring 5 x 3 cms just above the pinna of right ear with no surrounding wounds or blackening. The blast caused death of 18 persons at the spot while 70 received serious injuries. Suicide bomber also died at the spot and pieces of his bodies scattered there. Case FIR No. 471 dated 27.12.2007 was registered at Police Station City, Rawalpindi.

**Summary of Investigation Conducted by Punjab Police**

2. On inspection of place of occurrence, one pistol 30 bore alongwith a loaded magazine and one damaged magazine, one pistol 9-MM alongwith Magazine

and 5 live cartridges, two empty cartridges of 30 bore, two ball-bearings, pieces of leather jacket were taken into possession through recovery memos and sealed parcels of recovered items were prepared. Blood was taken through cotton from the place of occurrence and prepared sealed parcel of it. One electric circuit, one mobile phone SIM, one wrist watch, Identity Cards, visiting cards and blood stained pieces of cloth were also taken into possession through recovery memos from the place of occurrence. Human parts of the body i.e., 4 legs, 3 hands, piece of skull bone, one thumb and skin of fact of the suicide bomber were taken into possession from the place of occurrence, which were later on sent for DNA test. Face surgery of suicide bomber was got conducted for publication and identification. Site plan of place of occurrence without scale was prepared and later on site plan with scale was got prepared through draftsman.

3. On inspection of vehicle of Mohtarma Benazir Bhutto, her shoes and other material were taken into possession and sealed parcels were prepared. Blood and other material which were taken into possession from the place of occurrence and from the vehicle of Mohtarma Benazir Bhutto were sent to concerned department for analysis. All other vehicles which were damaged due blast, were taken into possession. Statements of P.Ws were recorded who verified the occurrence. Four injured succumbed to their injuries in the Hospital. Post mortem reports, MLRs, Chemical reports, Forensic Science Laboratory report and explosive expert report were taken from the concerned departments. A Joint Investigation Team (JIT) consisting upon Mushtaq Ahmed Sukhera DIG/CID, Waqar Ahmed Chauhan SP/Traffic Region-III, Tahir Ayub SP/Investigation, Rawalpindi, Inspector Tariq Ilyas and S.I. Ashfaq Ahmed of CID Lahore, under the supervision of Abdul Majeed, Addl. Inspector General of Police, CID Punjab investigated the case.

4. On the request of Govt. of Pakistan, a team from Scotland Yard police came in Pakistan. The team, after examining all the available and relevant evidence

stated that Mohtarma Benazir Bhutto died as a result of a severe head injury sustained as consequence of the bomb blast. J.I.T, took into possession the reports and CDs provided by the Scotland Yard Team.

5. The Interior Ministry provided J.I.T, a C.D, containing telephonic conversation (in Pashto language) from 'Amir Sahib' by telephone No.0928-234093 to 'Moulvi Sahib' on phone No.0965-238387, dated 28-12-2007. Two terrorists Aitzaz Shah alias Saifullah and Sher Zaman arrested from Dera Ismail Khan disclosed about the conspiracy hatched by Baitullh Mehsud and his companions for the assassination of Mohtarma Benazir Bhutto. After listening the intercepted telephonic conversation, accused Aitzaz Shah identified the 'Amir Sahib' as Baitullah Mehsud. He got recorded his confessional statement u/s 164 Cr. P.C, before the court.

6. During investigation accused Hasnain Gul alias Ali and Muhammad Rafaqat were also arrested from Rawalpindi. From their possession, hand grenade, detonators and bullets were recovered. Resultantly, Case FIR No. 76, dated 07-2-2008 u/s 13/20/65 A.O, ¾ ESA P.S. Westridge was registered. Both the accused got recorded their confessional statements u/s 164 Cr. PC in which they confessed their guilt and made inculpatory statements. They also disclosed the names of co-accused as Nadir Khan alias Qari Ismail r/o Swabi, Nasarullah alias Ahmed r/o Waziristan, Ibad-ur-Rehman alias Nauman alias Usman Ex-student of Madrassa Haqania, Akora Khattak, Abdullah alias Sadam r/o Mohmand Agency, Faiz Muhammad alias Kaskat r/o Swabi, Ikram Ullah r/o South Waziristan and the suicide bomber Saeed alias Bilal r/o South Waziristan, who fired at Mohtarma Benazir Bhutto and then blown him up. They also disclosed their links with Baitullah Mehsud. On the pointation of Hasnain Gull alias Ali certain articles (Jogger, Cap and Shawl) of the suicide bomber were recovered from his house.

7. Another arrested accused Rasheed Ahmed alias Abdul Rahim Turabi

(arrested on 14-02-2008) also disclosed in his confessional statement u/s 164 Cr. PC before the Magistrate that suicide bomber Saeed alias Bilal was handed over to Nadir alias Qari Ismail, Nasrullah alias Ahmed and Abdullah alias Saddam by Baitullah Mehsud alongwith Rs.4 Lac for the assassination of Mohtarma Benazir Bhutto. J.I.T also collected phone calls data of the accused which established close contacts of accused with each other, and that accused Nasrullah alias Ahmed, Hasnain Gull alias Ali and Rafaqat were present in the vicinity of place of occurrence. On 28-12-07 accused Nasrullah contacted 0965-238387. The same number was contacted by Ameer Sb on 28-12-2007 through PTCL number.0928-230493. Ameer sb was identified by accused Aitzaz as Baitullah Mehsud.

8. During the search for the accused, it transpired that Nadir Khan alias Qari Ismail and Nasrullah alias Ahmed on 15-01-2008 alongwith suicide bomber aged 14/15 years boarded in a car were intercepted at the Mohmand Rifle Check Post Masooma Khapakh, Mohmand Agency. Accused Nadir Khan alias Qari Ismail and Nasrullah alias Ahmed left the car and ran away. The Mohmand Rifle guards fired at them, Nadir Khan alias Ismail died on the spot whereas suicide bomber blew him up. Accused Nasrullah alias Ahmed died in the Hospital. The remaining accused are still at large and efforts are being made to arrest them.

9. During the course of investigation, it transpired that accused Aitzaz Shah, Sher Zaman and Rasheed Ahmed had information regarding the conspiracy of assassination of Mohtarma Benazir Bhutto but they did not inform the police or some other agency deliberately, so challan u/s 6/7-11-L, ATA has been sent up in the court. All the three accused are in judicial custody.

10. Similarly, accused Hasnain Gull alias Ali and Muhammad Rafaqat (arrested in judicial custody) as well as Ibad-ur-Rehman alias Nauman alias Usman, Abdullah alias Saddam, Faiz Muhammad alias Kaskat, Baitullah Mehsud and

**Trial in Court**

11. After completion of investigation the local police have submitted incomplete Challan in Anti- Terrorism Court No. I, Rawalpindi on the basis of incriminating evidence based on confessional statements of four accused persons. On receipt of Challan by the local police the learned trial Court has taken the cognizance into the matter and framed charge against the accused persons and commenced the trial. During the trial, the Court recorded statements of three P.Ws. Since Sardar Muhammad Ishaq Khan, Advocate was appointed, Special Public Prosecutor by the Punjab Govt. who during trial got framed charge against accused persons in ATC-I Rawalpindi on 22.11.08.

12. The subject case was transferred to FIA by M/o Interior Government of Pakistan vide Office Order No. 1/1/2008-DS (FIA), dated 06.8.2009 while constituting JIT in terms of Section- 19(1) of ATA 1997 for further investigation of the case. On 22.8.2009 as per direction of the Federal Government Mr. Shah Khawar, Deputy Attorney General moved application in the Anti- Terrorism Court No. I, Rawalpindi for adjournment of the trial proceedings till completion of investigation by the FIA. The learned trial Court after hearing the argument from both the sides adjourned the trial proceedings from time to time.

13. Ministry of Interior Government of Pakistan notified the transfer of the case to FIA for further investigations vide letter no. 1/1/2008/DS(FIA) dated 06-08-2009 and constituted JIT to be headed by Director SIG. AD Shoaib Ahmad was notified as investigating officer of the case. Subsequently Mr. Wajid Zia Director ECW FIA, Mr. Sohail Habib Tajik Additional Director SIG FIA, Mr. Azad Khan

Additional Director SIG Karachi, Mr. Ghulam Asghar Jatoi Assistant Director FIA Karachi were notified as members of JIT. Mr. Shah Khawar Deputy Attorney General on 17.08.2009 moved the Anti Terrorism Court Rawalpindi for adjournment of the trial.

### **Further Investigations**

#### **14. Tasks Undertaken By FIA JIT**

- a. Police investigation mainly relied upon confessional statements of 04 accused, which have been corroborated.
- b. Statement of author of intercepted CD recorded.
- c. Statements of concerned officials of mobile phone companies u/s 161 Cr. PC recorded.
- d. Call record of all linked phone numbers of suspects obtained for identification of active terrorists.
- e. Proper analysis of suspect's phone numbers conducted.
- f. 02 diaries containing telephone numbers recovered from Hasnain Gul analyzed.
- g. Arrest of POs.

#### **Record of Accused Verified From Madrassah Darul uloom Haqqania in Akora Khattak, District Nowshera**

15. During the earlier investigation it was reported that some of the accused had studied and resided in Madrassah Darul Uloom Haqqania, Akora Khattak before and during the day of occurrence of Liaquat Bagh, Rawalpindi. Hence, Government of Khyber Pakhtunkhwa was requested to provide necessary assistance to the JIT to verify Madrassah record on the spot. On 12.05.2010 SIG Team headed by Inspector Naseer Ali Khan visited Madrassah Darul Uloom Haqqania, Akora Khattak and met Mr. Wasal Ahmed, Nazim-e-Talimaat.

16. Nazim-e-Talimaat produced all the relevant registers of admission and

discharge from Madrassah for inspection of investigation team. The investigation Team checked all the registers in order to identify accused involved in the assassination of Mohtarma Benazir Bhutto in Rawalpindi. During the inspection complete particulars of the following accused were detected by the investigation team: -

- a. Abdullah @ Saddam S/o Ali Rahman R/o Village Lakaro, Mohmand Agency  
(original admission form)
- b. Nadir @ Qari Ismail S/o Musafar R/o Khazana Kalabat, District Swabi.  
(Original admission form).
- c. Rasheed Ahmed @ Abdur Rahim Turabi S/o Quadrat Shah R/O Village Srikh Morzai, P.O. Batagram, Tehsil Shabqadar, District Charsadda  
(original admission form).
- d. Faiz Muhammad S/o Shah Nazar R/o Village Zaida, District Swabi.  
(original admission form).

17. The investigation team seized original forms pertaining to the above mentioned accused persons vide Registration No. 21716, 17816, 18642 and 23629, Mr. Wasal Ahmed, Nazim-e-Talimaat in his statement u/s 161 Cr. P.C promised to produce the original admission registers in court as and when required. The investigation team during inspection of record found that the above mentioned four accused involved in the assassination of Mohtarma Benazir Bhutto remained students of Madrassah Haqqania, as a result their complete particulars have been confirmed.

18. Mr. Wasal Ahmed, Nazim-e-Talimaat in his statement u/s 161 Cr. P.C also disclosed that accused Said Arab, S/o Azim Khan R/o Chota Lahore, Swabi, Gul Roz S/o Ali Akbar R/o Chota Lahore Swabi, Muhammad Shafique S/o Badshah Gul R/o Gar Tajik Peshawar and Rasheed Ahmed @ Abdul Raheem Taribi S/o Quadrat Shah R/o Village Srikh Morzai, P.O Batagram, Tehsil Shabqadar, Distt. Charsadda were also students of Darul Uloom Haqqania and were arrested by Police in Kamra Missile Attack case 2008 for their alleged connection with Tehrik Taliban Pakistan.

**Verification of Death of Accused Nasrullah @ Ahmed and Nadir @ Qari Ismail in Mohmand Agency**

19. SIG team visited Khapakh check post, Ghalanai Mohmand Agency to verify the reported death of two accused Nasarullah and Nadir on 15-01-2008. SIG team met Addl Political Agent Saeed Ahmed Jan and Asst Political Agent Roshan Khan Mehsud who verified that according to record, on 15-01-2008 a Jeep was stopped by MR at Khapakh check post. Two of the three persons sitting in the jeep tried to escape; whereas, the third one who was a young boy of 10/11 years remained seated in the jeep who later of exploded himself. One of the two fleeing persons was shot dead who was later identified as Nadir @ Qari Ismail, r/o Khazana Kalabat and the second fleeing person was over powered by MR personnel and was identified as Nasarullah r/o Dandi Sedgi. Nasarullah was taken to hospital where he died after 6/7 days and his dead body was shifted to Ghalanai Hospital. A CNIC was recovered from the dead body belonging to one Nadir s/o Musafar r/o Khazana Kalabat, District Swabi. Nasarullah's dead body was handed over to a person named Noroz Khan s/o Haji Jan Khan r/o Dandi Sedgi, P.O Meran Shah, Tehsil Ghulam Khan, North Waziristan, bearing CNIC No. 21504-6212434-1 where he was buried. SIG team obtained copies of the following documents from the office of Political Agent Mohmand Agency:-

- a. Letter of Political Agent (DSR-ii).
- b. Special Report of Naib Tehsildar (15-01-2008).
- c. Letter No. 316 of Political Naib Tehsildar.
- d. Letter of Naroz Khan who received dead body of Nasrullah.
- e. Attached copies of telephone numbers and addresses.
- f. Photocopies of CNIC of Noroz Khan.



**DNA Comparison Report by FBI Laboratory.**

20. Accused Hasnain Gul was arrested by police on Jan 05, 2008. He subsequently made confessional statement u/s 164 CrPC before the learned Magistrate. His confession included that 02 suicide bombers namely Bilal and Ikramullah stayed at residence of his arrested co-accused Muhammad Rafaqat on Dec 26, 2007. Furthermore, on Dec 27, 2007 Hasnain Gul got the 02 suicide bombers prepared at his residence for launching the suicide attack on Mohtarma Benazir Bhutto. While leaving in accused Rafaqat's taxi the suicide bombers left one shawl, a pair of joggers and a cap at the residence of accused Hasnain Gul.

20. The Shawl, pair of joggers and the cap was seized by Rawalpindi police on Feb 11, 2008 from the residence of arrested accused Hasnain Gul r/o Rawalpindi on his pointation. JIT sent these items to FBI DNA Laboratory, Quantico USA through US Legal Attache office, US Embassy Islamabad vide SIG HQ letter No. HQ/SIG/Ops/471/09/1985-87, dated: Sep 12, 2009 to obtain DNA profiles from above mentioned articles for comparison with DNA profiles already prepared by Armed Forces Institute of Pathology (AFIP), Rawalpindi vide their report No: DNA-01/2008 (addendum), dated Jan 04, 2008, from following body parts of three different individuals:-

- a. Piece of soft tissue adjacent to teeth.
- b. Reconstructed face.
- c. Intact right hand without index finger.
- d. Thumb.
- e. Soft tissue from tongue.
- f. Piece of soft tissue.

- g. Left leg with woolen socks and red shoes.
- h. Right leg with woolen socks and red shoes.
- i. Right leg with black socks and brown leather chappal.
- j. Left leg with black socks and brown leather chappal.
- k. Left hand without thumb with stains of Mehndi on its palmer aspect.
- l. Right hand complete.

21. US Legal Attache office, US Embassy, Islamabad vide its letter No. IS-C163-A, dated: Mar 26, 2010 has provided final DNA result of FBI Laboratory's forensic DNA examination. The report has verified that the DNA profiles of two individuals prepared by AFIP, Rawalpindi from Piece of soft tissue adjacent to teeth, Reconstructed face, Intact right hand without index finger, Thumb, Soft tissue from tongue, Piece of soft tissue, Right leg with black socks and brown leather chappal, Left leg with black socks and brown leather chappal (**Unknown 1**) and Left leg with woolen socks and red shoes, Right leg with woolen socks and red shoes (**Unknown 2**) has been found present on Shawl and pair of joggers recovered from house of accused Hasnain Gul mentioned above.

22. Comparison report of FBI Lab has corroborated Hasnain Gul's confessional statement by confirming that 02 terrorists who left Shawl and pair of joggers and cap in Hasnain Gul's residence were killed in the blast on crime scene in Liaquat Bagh on 27-12-2007.

**Forensic Report of Cell phones recovered from Accused Hasnain Gul and Muhammad Razaqat.**

23. At the time of arrest of accused Hasnain Gul and Muhammad Razaqat on Jan 05, 2010, police recovered following 03 cell phone numbers from their

possession:-

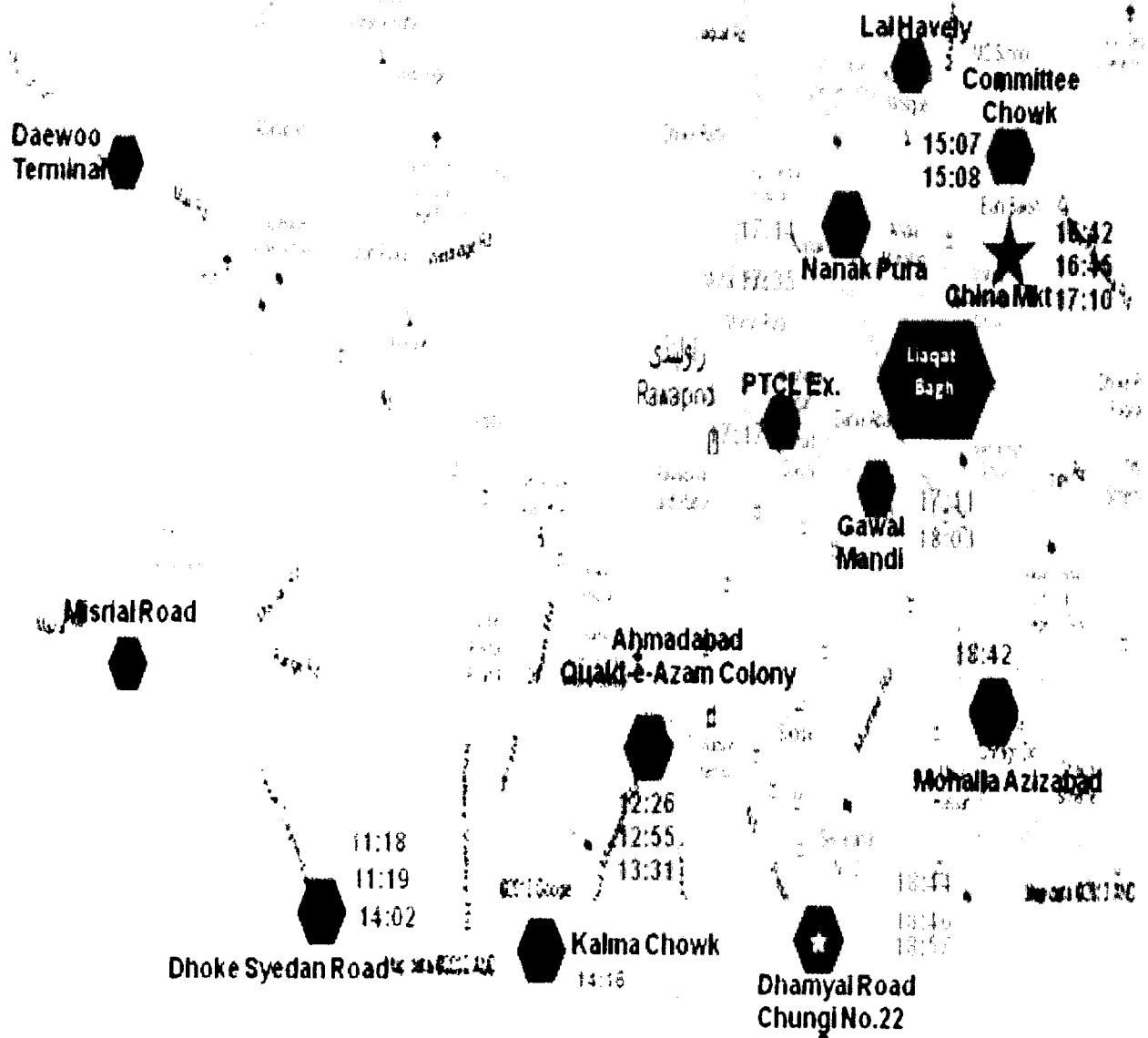
24. Forensic examination of above mentioned cell phone numbers was conducted in SIG Computer Forensic Laboratory. **The IMEI analysis of above mentioned cell phones has revealed that the cell phone recovered from Muhammad Rafaqat (with IMEI 356405012608494) at the time of arrest was in use of Hasnain Gul on the day of occurrence i.e 27-12-2007.**

**RBS Locations of Accused Hasnain Gul, Muhammad Rafaqat and Nasarullah.**

25. Accused Hasnain Gul and Muhammad Rafaqat were arrested by police on Jan 05, 2008. They subsequently made confessional statement u/s 164 CrPC before the learned Magistrate. In their confessional statements both have revealed that they received 02 suicide bombers namely Bilal and Ikramullah along with accused Nasarullah (killed in Momand Agency on 15-01-2008) near Daewoo terminal Rawalpindi on Dec 26, 2007. Both of them disclosed their activities including reconnaissance of Liaqat Bagh on Dec 27, 2007 by Rafaqat and Nasarullah and bringing the 02 suicide bombers to the crime scene for suicide attack on Mohtarma Benazir Bhutto.

26. During call record analysis RBS locations were analyzed which corroborated the confessional statements of both arrested accused Hasnain Gul and Rafaqat Hussain by corroborating the location and timings revealed by them in their

confessional statements which is shown in following map (26-A).

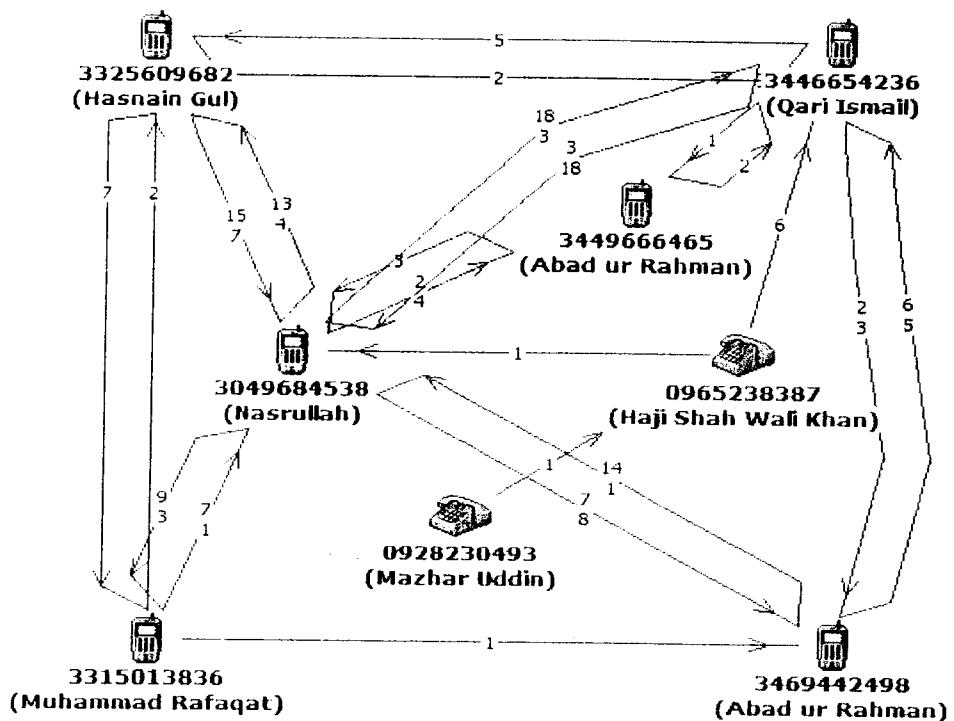
27. The call data record of cell phone numbers of the following accused has been analyzed by SIG i2 Analyst:-

28. The analysis has revealed that Nasrullah, Hasnain Gul, Muhammad Rafaqat, Qari Ismail, Abad ur Rahman and the two PTCL numbers mentioned above are interconnected as shown in the chart below between 02-12-2007 to 27-01-2008 while accused were involved in planing, facilitating and execution of suicide bombing attack against Mohtarma Benazir Bhutto in Rawalpindi and subsequent escape from Rawalpindi to Dir etc.

29. The above mentioned PTCL number 0965238387 in Tank is the number on which one Moulvi Sb received a call from one Amir Sb (Bait Ullah Mehsud) from the above mentioned PTCL number 0928230493 in Bannu / Miranshah on 28-12-2007, which was intercepted by ISI. The same PTCL number in Tank had already called Nasarullah before he was called by Ameer Sb.

**Gist of Statement of Special operator of ISI**

30. Muhammad Ismail operator ISI Islamabad stated that he has been appointed in ISI for almost 05 years and he is well versant with Pushto Language. His duties include hearing and recording telephonic conversation of commanders of different organizations. On 28-12-2007 during interception of routinely under observation telephone numbers, ISI intercepted a telephone call from a phone number 0928-230493 (registered in the name of Mazhar uddin) to a phone number 0965-238387 (registered in the name of Haji Shah Wali Khan). Through experience he identified the caller from the phone number 0928-230493 as Bait ullah Mehsud. He recorded the conversation on the CD whose duration was 01 minute and 13 seconds.

**Corroboration of Association of Cell Phone Numbers with Accused**

31. Call record analysis of cell phone numbers of arrested accused Hasain Gul and Muhammad Razaqat (0332-5609682 and 0331-50138336 respectively) has further corroborated that the above mentioned numbers were in use of arrested accused Hasnain Gul and Muhammad Razaqat as Hasnain Gul called the landline number installed at the residence of Muhammad Razaqat and the cell phone in his use on 27-12-2007 (the day of occurrence ) was recovered from Muhammad Razaqat at the time of arrest. Further more the cell phone numbers disclosed by Muhammad Razaqat to be in his use on 27-12-2007 (the day of occurrence) was in contact with a cell phone number 0300-2594556, which was in use of Shahzad (brother of Muhammad Razaqat), moreover the cell phone number of Muhammad Razaqat was in

contact with two other cell phone numbers which are registered in the name of Sabir Hussain (father of Muhammad Razaqat).

**Efforts to Arrest POs Through Sources, Surveillance and Interception.**

32. JIT had deployed and utilized all the sources to affect the arrest of absconding accused (mentioned in column No. 2, of challan in Red Ink) through informers and surveillance by intelligence agency. Ibad-ur-Rehman @ Farooq Chattan was last located near Bara and Landi Kotal in Khyber Agency. According to sources he was involved in conducting terrorist attacks in Peshawar, Swat, Rawalpindi and other areas of Pakistan on behest of TTP and Al-Qaeda. JIT has held a number of meetings with the officials in Frontier Corps HQ Bala Hisar, Corps Headquarters Peshawar and ACS FATA Peshawar to locate the remaining POs.

**Fixing Responsibility For Breach of Security, Destruction of Evidence & Failure to Conduct Postmortem.**

33. During investigation the JIT also examined a number of persons through recording of their statements and issuance of questionnaires in order to identify other accused, if any, involved in the criminal conspiracy for assassination of Mohtarma Benazir Bhutto in Rawalpindi. The JIT also investigated role of relevant Police Officers for failure to provide proper security arrangements for Mohtarma Benazir Bhutto, negligent washing of crime scene, failure to get conduct postmortem etc which either contributed directly to the assassination of Mohtarma Benazir Bhutto or subsequently impeded investigation due to insufficient crime scene evidence. JIT has also made every effort to determine whether the accused persons mentioned in col. No. 3 in challan, including those who are Pos, received any support or facilitation or instigation from any government & public functionary, etc and whether any Police officer deployed on duty in Liaquat Bagh Rawalpindi on the day of occurrence had any role by intentional omission or commission in facilitation of the execution of

assassination plan of Mohtarma Benazir Bhutto. The JIT also examined concerned responsible officials regarding motive of press conference of Brig. ® Javed Iqbal Cheema, Ex-Director General, National Crisis Management Cell, M/o Interior, Islamabad.

34. During the process the JIT recorded the statements of following persons & officials: -

35. JIT has already submitted supplementary incomplete challans in the Trial Court on 25<sup>th</sup> May 2010 and 11<sup>th</sup> June 2010. During this period JIT co-ordinated its efforts with the Frontier Corp Peshawar, Frontier Constabulary, Frontier Police and FATA Secretariat to apprehend POs namely Ibad ur Rahman @ Noman @ Farooq Chatan, Abdullah @ Saddam & others in FATA and adjoining areas in Khyber Pakhtoonkhwa. Since security operations are being carried out in FATA a great difficulty was faced to access these areas for apprehension of the absconding accused. Furthermore during last two years most of the previous top leadership of TTP and Al-Qaida has been eliminated in South Waziristan, Mohmand and Bajur agencies. Likewise telephone record of suspects is not available beyond 3 months. All these impediments made the arrest

of Pos difficult for JIT.

However, a source in Khyber Agency has provided a video to JIT indicating death of P.O Ibad-ur-Rehman @ Farooq Chatan along with 14 other Taliban militants including foreigners in a drone attack on 13<sup>th</sup> May, 2010 in Tirah, Khyber Agency.

Likewise, the death of PO Abdullah @ Saddam was confirmed by his brother Bahlol Khan S/o Ali Rehman, R/o Garbaz, PO Lakray, Tehsil Upper Mahmand, Mahmand Agency. He stated that his brother Saddam died in a bomb blast on 31<sup>st</sup> May 2008 at Mamad Gatt, Mohmand Agency and he was buried in his native village Lakaro, Mohmand Agency.

36. Furthermore, during investigation it has been established that conspirators and accused studied and stayed at Madrassah Haqania, Akora Khattak during 2006 & 2007. Apparently JIT Punjab Police did not contact management of Madrassah Haqania, Akora Khattak to procure the relevant record. In this regard SIG, Peshawar has seized all the relevant record pertaining to accused from Madrassah Haqania, Akora Khattak. As mentioned earlier there is no doubt that accused Nasrullah, Saddam & their associates etc were students and resident of Madrassah Haqania while they were hatching conspiracies and planning to assassinate Mohtarma Benazir Bhutto. However, so far the JIT has not come across evidence of any role of abetment, incitement or facilitation by any member of management of Madrassah Darul Uloom Haqania Akora Khattak in the actual suicide attack on Mohtarma Benazir Bhutto on December 27, 2007.

37. As mentioned earlier, JIT has conducted extensive investigation to determine liability of Police Officers of Rawalpindi Police who

were responsible for providing comprehensive security cover, protection of crime scene and carrying out initial investigation as per law. In this regard JIT has recorded statements of number of witnesses. PW Ashfaq Anwar, SP in his statement recorded u/s 164 Cr. P.C has disclosed that approximately two hours before the departure of Mohtarma Benazir Bhutto from Liaquat Bagh, CPO Syed Saud Aziz removed him from the escort duty of Mohtarma Benazir Bhutto and sent him to Karal Chowk, Islamabad for inquiring into an alleged firing incident. This sudden removal of SP Ashfaq Anwar by the then CPO Syed Saud Aziz from Escort duty of Mohtarma Benazir Bhutto caused a security breach which facilitated the terrorists to carry out a successful suicide attack in close proximity of Mohtarma Benazir Bhutto's vehicle resulting in her assassination. Statement of SP Ashfaq Anwar is duly supported by PWs SP Tahir Ayub, SP Javed Iqbal, SSP Dr. Moeen Masood and Inspector Azhar Hussain Shah. Furthermore, this vital fact of deliberate removal of Mohtarma Benazir Bhutto's security officer at a crucial juncture was determined by this investigation.

38. Based on reliable and irrefutable ocular evidence JIT has found that Rawalpindi Police Officers CPO Syed Saud Aziz, and SP Khurram Shehzad are directly responsible for intentional destruction of evidence from crime scene through a deliberate and totally unwarranted order for washing of crime scene. In this regard statements of PWs Dr. Abdur Rehman, Emergency officer Rescue-1122, and Mr. Ghulam Muhammad Naz, Assistant Fire Officer have been recorded under Sec- 164 Cr. PC. They have stated that the crime scene was washed on the orders of SP Khurram Shehzad.

While SP Khurram Shehzad stated that prior to washing the crime scene he had obtained orders from CPO Saud Aziz on phone. When CPO Syed Saud Aziz and SP Khurram Shehzad were confronted with this evidence they admitted that they ordered the washing of crime scene because in their opinion all relevant evidence had been collected from the crime scene. However, when further confronted with the seized articles they couldn't point out a single seized article which provided any lead for investigation. These officers couldn't justify the washing of crime scene in a hasty and arbitrary manner. It is emphasized that as a result of washing the crime scene the opportunity to find additional incriminating evidence in such an important case was lost.

39. JIT has also found that CPO Syed Saud Aziz deliberately avoided to get conduct the post mortem in an attempt to obstruct and impede investigation. In this regard statement of PW Prof. Dr. Mussadaq has been recorded u/s 164 Cr. PC. CPO Syed Saud Aziz in his statement before JIT tried to shift this legal responsibility but JIT finds his explanation as implausible and untenable.

40. JIT has also scrutinized the role of Punjab Government functionaries and other public functionaries. In this regard the then Home Secretary Mr. Khusro Pervaiz was also examined. After examining all the statements and relevant record it can be stated with confidence that while Govt. of Punjab detained Mohtarma Benazir Bhutto during the same period on the pretext of 'security reasons' and also banned Mohtarma Benazir Bhutto rally at Rawalpindi, but the same Government of Punjab failed to adopt

sufficient security measures for Mohtarma Benazir Bhutto on 27.12.2007. In this regard JIT would like to mention here for comparison the security measures taken by Government of Sindh on 18.10.2007 for Mohtarma Benazir Bhutto when she survived the twin suicide attacks at Karsaz, Karachi due to layered and alert police security arrangement and provision of armoured truck/ escape vehicle. However, no evidence has surfaced so far, which would indicate the involvement of functionaries of Punjab Govt. in the assassination of Mohtarma Benazir Bhutto.

41. Similarly, the JIT also interviewed and issued questionnaires to a number of Federal Government functionaries including the then Secretary Interior, the previous DG IB, the then DG, NCMC, the then Director Technical IB, the then JD IB, ICT Islamabad etc. It is abundantly clear that while Federal Govt. was in possession of sufficient material to indicate imminent threat to the life of Mohtarma Benazir Bhutto from Al-Qaida and Taliban, yet the Federal Govt. did not provide appropriate level of security to Mohtarma Benazir Bhutto in Punjab or Rawalpindi. This security lapse in Rawalpindi is significant because Mohtarma Benazir Bhutto had already suffered and barely survived the twin suicide attacks on 18.10.2007 at Karsaz incident Karachi. While the then Federal Govt. has contended that security in Punjab is a provincial matter, the same Federal Government had notified VVIP security arrangements for Mr. Shaukat Aziz, Ex Prime Minister and Ch. Shujaat Hussain, Ex-Prime Minister but did not notify such security arrangements for Mohtarma Benazir Bhutto who remained Prime Minister of Pakistan twice and was Chairperson of Pakistan Peoples

Party. The concerned officials have not provided a satisfactory explanation for this lapse on their part.

42. In the same manner JIT found that the then Federal Government again took over responsibility of Provincial Government when DG, NCMC, Ministry of Interior held a press conference on 28.12.2007. In this press conference the then DG, NCMC not only announced cause of death of Mohtarma Benazir Bhutto but also declared that the terrorists belonged to Baitullah Mehsud, Chief Commander, TTP. The credibility of investigation of this case was affected by the premature press conference mentioned above.

43. It is evident from the above paragraphs that the conduct of then Provincial and Federal Govt. functionaries on 27.12.2007 and in the subsequent days was not up to the mark. Resultantly, a number of controversies cropped up because of this premature and hasty press conference and lack of adequate security measures provided to Mohtarma Benazir Bhutto. However, JIT has so far not come across any evidence regarding abetting and facilitating terrorist attack on 27.12.2007 on Mohtarma Benazir Bhutto at Liaquat Bagh Rawalpindi by any functionary of Provincial or Federal Government. Despite efforts the JIT has not been able to examine Gen. (R) Pervaiz Musharaf in this regard till so far.

44. Furthermore, the Ministry of Foreign Affairs vide letter No. Afg(II)-1/15/2010, dated 3<sup>rd</sup> March 2010, replied to JIT that they don't possess any warning or report issued on their record by President Hamid Karzai of Afghanistan regarding any threat to

Mohtarma Benazir Bhutto's life. Similarly, vide CC No. 1-1200 Dated 5<sup>th</sup> May 2010, PAREP Abu Dhabi has informed that according to UAE authorities they had received information on a serious threat of life to Mohtarma Benazir Bhutto, which was conveyed to Mohtarma as well as ISI. But they did not have specific information either on the identity of the planners or those who carried out the assassination.

45. As already pointed JIT also examined a number of important political leaders. While these persons pointed various weaknesses in security of Mohtarma Benazir Bhutto but none of them provided any vital or additional evidence in this regard.
46. JIT made an attempt to seek additional evidence from UN because UN Commission on assassination of Mohtarma Benazir Bhutto had pointed out at a number of other aspects of the case. However, Ministry of Foreign Affairs Government of Pakistan vide u.o note No. UN(I)-8/42/2007 dated 22 July 2010 has conveyed to the JIT that no such evidence is forthcoming.
47. In order to seek assistance from Sindh Police, JIT met Mr. Saud Ahmed, Addl. IGP CID, Sindh to discuss the progress made in FIRs 183/ 07 and 213/ 08 PS Bahadurabad, Karachi, pertaining to suicide attacks on Mohtarma Benazir Bhutto on 18 October 2007 in Karsaz, Karachi. Apart from this DSP Mr. Nawaz Ranjha the I.O of the said case was also called to Islamabad. The case file was examined and thoroughly discussed with him. However, so far Karachi Police has not provided any substantial clue which could be useful in the investigation of the instant case.

**Conclusion:**

48. JIT has minutely examined the statements of witnesses, confessional statements of accused, accused call record analysis, DNA comparison report, cell phone forensic report, Darul Uloom Haaqania Akora Khattak record, Medico Legal Certificates of deceased, statement of ISI official etc.

49. It is evident from the evidence available on record that accused Hasnain Gul & Muhammad Razaqat carried out suicide attack against Mohtarma Benazir Bhutto in Rawalpindi with active support, facilitation, financing, guidance, abetment and provision of suicide bombers & explosive jackets by Nasruallah, Abad-ur-Reham, Nadir @ Qari Ismail, Abdullah @ Saddam and Faiz Muhammad @ Kisket. Similarly Aitzaz Shah accused in confessional statement admitted knowlegde of conspiracy and identified the voice of Baitullah Mehsud, Amir of Tehrik Taliban Pakistan (TTP) on intercept by ISI. Similarly accused Aitzaz Shah in his inculpatory confessional statement recorded by the Magistrate has implicated his co-accused Sher Zaman with the commission of offence with which he has been charged. Likewise accused Rasheed Ahmed @ Abdul Rahim Turabi in his inculpatory confessional statement recorded by the Magistrate also implicated his co-accused for having knowledge of the criminal conspiracy to assassinate Mohtarma Benazir Bhutto. JIT has brought corroborative and concrete evidence against the accused mentioned in Col. No. 03 of the challan including FBI DNA Comparison Report, SIG Forensic Expert Report, SIG i-2 Analyst Report, Record seized from Daruloom Haqania Akora Khattak, RBS location of accused Hasnain Gul & Muhammad Razaqat and Nasrullah in Rawalpindi





on 27.12.07 i.e. day of occurrence.

50. During the investigation JIT has with the permission of court re-examined & interrogated all the accused mentioned in Col. No. 03 of the challan & confined in Judicial Lockup. The accused admitted their guilt and have not expressed any remorse or repentance for their brutal criminal act and made their voluntary confession u/s 164 CrPC.
51. As mentioned above substantial evidence has been brought on record against Mr. Saud Aziz, former CPO Rawalpindi regarding his role in causing breach of security by withdrawing police officer deputed for Mohtarma Benazir Bhutto's escort duty, destruction of evidence by ordering washing of crime scene, and avoiding to conduct post mortem of Mohtarma Benazir Bhutto, all of which acts have resulted in firstly facilitating assassination of Mohtarma Benazir Bhutto and subsequent damage to the investigation of the case. Similarly sufficient evidence has come on record against SP Khurram Shehzad for ordering washing of crime scene which resulted in destruction of evidence. It is also evident that breach of security provided terrorists the opportunity to carry out a successful attack on Mohtarma Benazir Bhutto resulting in her assassination. Based on the evidence available on record prima facie a case u/s 109, 119 and 201 PPC is made out against accused Syed Saud Aziz, former CPO Rawalpindi and Khurram Shehzad the then SP Rawal Town, Rawalpindi. Hence their names are placed in Column No. 2 of the Challan due to lack of direct evidence of connection between accused Police officers and terrorists accused mentioned in column No. 3 of the challan.
52. Sufficient oral as well as documentary evidence is available on

record alongwith scientific evidence which directly connects all the accused persons mentioned in Column No. 3 of the Challan including the POs accused mentioned in Col. No. 2 of the Challan with red ink with the commission of offence. The accused mentioned in Col. No. 2 of the Challan with red ink and accused mentioned in Col. No. 3 of the Challan have been found guilty on the basis of sufficient incriminating evidence available on record against them mentioned in Col. No. 5 & 6 of the Challan. Prima facie a case u/s 6/ 7/ 11- L/ 21-I/ 21-C Anti Terrorism Act, 1997, R/W section 4/5 ESA 1908, 302, 324, 435, 436, 109, 120-B. 118 119, 201 PPC is made out against the accused persons mentioned in column No. 2 of the Challan with red ink and accused mentioned in Col. No. 3 of the Challan. All the earlier Challans already submitted in the Court by the Rawalpindi Police and FIA are integral part of this Challan and all evidence annexed with these Challans may please be read with the instant Challan. That (incomplete) supplementary challan is being submitted in the court alongwith list of witnesses and other evidence with the prayer to summon the witnesses mentioned in Col. No. 6 of the Challan and trial be initiated against all the accused persons accordingly.

We safely reached Liaquat Bagh within 15/20 minutes as per schedule. My responsibility of escorting her to the designated venue i.e. Liaquat Bagh was performed professionally and without any untoward incident.

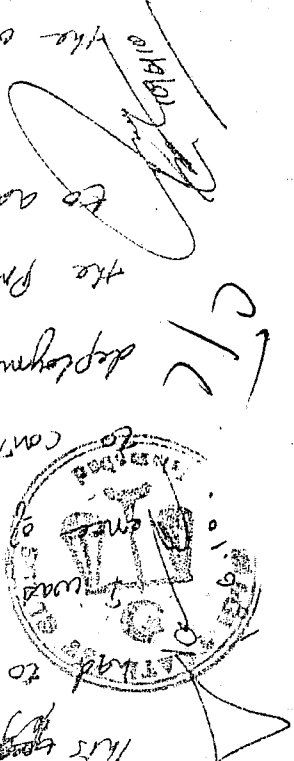
2- After BB's arrival at Liaquat Bagh I remained present there till 1515 hrs when I was ordered by Mr. Sand Aziz the then CPO Rawalpindi on my cell phone to rush to Karal Chowk alongwith two stand-by Police Reserves due to an alleged firing between members of two Political Parties (PML-N & PML-Q) in which <sup>precious</sup> human lives were lost.

On receipt of the <sup>order</sup> from Mr. Sand Aziz <sup>there</sup> the then CPO Rawalpindi through <sup>my</sup> <sup>cell</sup> <sup>phone</sup> I left Liaquat Bagh with the directions to incharge elite sections Inspector Azmat Dogar to remain vigilant on duty with his forces I accordingly reached Karal Chowk at 1540 hrs as it is about 7/8 km from Liaquat bagh and met with Dr. Moiz Masud, the then Addl. SP, Islamabad. by Mr. Sand Agis the then CPO Ramprasad to deploy the force with me around the house of Hajji Nayag Khokas from where the firing was alleged. Four persons were killed in this incident which was duly entered later on in an F.I.R. No 101/2007 at PS Karal, Siston and. The house of Nayag Khokas is situated within the territorial limits of District Bangalore while the persons killed on the Express-way were in the jurisdiction of Siston and Karal. This was why Police Agis both from Ramprasad and Siston were to go there. Before his departure from Karal check verbally directed by then CPO Ramprasad in the presence of IJed Sibel, the then SP, security, Ramprasad deployment of force force at Sidiyada check house the PM (N) Leader Mr. Nayag Agis was scheduled to address a public meeting in Mysore on 11/6/10.



My deployment as an officer in subject to the orders of CPO Ramprasad and in the sequence given above I followed the same in Karal and Spon. In order to implement the urgent orders of Mr. Sand Agis the then CPO Ramprasad, I alongwith force reported to Mr. John Agis the then SP investigations, Ramprasad at Sidiyada check on arrival I found there that one Inspector Agis was already deployed. I issued necessary instructions for booking up security there with my resources as per the order of CPO Ramprasad. I

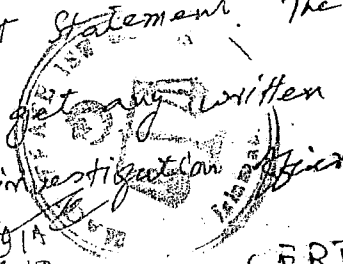


remained here till 1830 hrs when SSP/operations  
Rawalpindi Yaseen Farooq ordered all SSP and  
SDPOs to reach RGH Rawalpindi alongwith Reserve  
Police. I along with Two Reserve Police reached  
RGH Rawalpindi.

The tragic occurrence of martyrdom of Benazir  
Bhutto was condemned all around the world and  
the matter became so prominent that ultimately  
investigation through a UN team was asked for.  
Everybody concerned wanted to find a scapegoat so  
that concerned persons can get a clean chit. In this

background, a meeting of Senior Police Officers was held  
in police college Rawalpindi and after the meeting  
I was called by Saad Aziz the then CPO to see my  
statement about the incident with Mujahid Hussain the  
then DSP Saddar Rawalpindi. I however refused to  
agree to the already drafted statement and submitted  
that every Police has an assigned role and therefore  
facts should be brought on record as there were.  
My refusal was not well taken but I did not agree to  
give any statement except the facts as reflected in  
my present statement. The UN enquiry team also  
did not get any written statement from me nor  
did any investigation officer examine me.

STATEMENT U/S 161 CR.PC OF MR. GHULAM MUHAMMAD NAZ S/O MUHAMMAD ISMAIL, EX- ASSISTANT FIRE OFFICER, CITY DISTRICT GOVERNMENT, RAWALPINDI. R/O FLAT NO. 1, MOHALLA FIRE BRIGADE QUARTERS, LIAQUAT ROAD, RAWALPINDI. CNIC NO. 37405-5413307-1. TELE. No. 051- 5532396 (CELL) NO. 0334- 5001122.

State that I was born on 01.05.1949 in Sri Nagar, Kashmir. Later, my parents migrated to Pakistan and settled in Rawalpindi. My educational qualification is Matric did from Islamia High School No. 3, Dhoke Ratta Amral, Rawalpindi in the year about 1982. I started my service carrier as Clerk with defunct Municipal Corporation, Rawalpindi in the year 1980. After about two years I joined fire service as a Fire Station Incharge and retired on 30.4.2009 as Assistant Fire Officer.

2. On 27.12.2007, there was scheduled congregation / public gathering of Pakistan Peoples Party Parliamentarian in Liaquat Bagh, Rawalpindi at the noon time, where ex- Prime Minister and Chairperson of the party Mohtarma Benazir Bhutto was scheduled to address the said gathering in connection with the coming elections. Our department was made alert by the higher authorities i.e. District Administration to resolve / face any unwarranted incident / occurrence, therefore, I was present in Fire Station, Liaquat Bagh, Rawalpindi, along with my subordinate staff, which was at the distance of about one & half furlong from Liaquat Road i.e. place of incident. At about 5:12 p.m a message regarding bomb blast in the Pakistan Peoples Party Parliamentarian public gathering was received by me on wireless. I immediately alongwith my vehicle and staff rushed to the scene where the incident taken place, no fire scene was there. However, dead bodies and the injured people were lying there. By that time the Ambulances of the Rescue - 112 and subsequently the Edhi Ambulances also reached over there. The Rescue people with the help and assistance of other organizations and NGOs including my staff started to pick the injured people and sent them to the District Headquarter Hospital, Fuwara Chowk, which is at the distance of about one kilometer. Thereafter, the dead bodies were collected and were sent to the District Headquarter Hospital for their autopsy and other legal action by the respective doctors and police. Dr. Abdur Rehman the then Emergency Officer now District Emergency Officer of Rescue - 1122 was present at the spot who was supervising the rescue and first aid to the injured people. After removing the injured people and dead bodies of the human being, the police and bomb disposal staff were busy in collecting the requisite material / articles as a piece of evidence of the incident. At about 6:20 p.m, one police official (ASI) name not known, in uniform approached me and conveyed the message / order of his some senior officer to wash the crime scene, as they according to him have collected the required material / evidence. Since, Dr. Abdur Rehman, Emergency Officer of Rescue - 1122 was present there,

therefore, I discussed about the message of the said police officer with him. Dr. Abdur Rehman did not agree with the order of police department and asked me to wait and let him to consult the issue with some senior police officer. Dr. Abdur Rehman went to the Senior Police Officer who was supervising the police working and his staff present over there and discussed about the hosing down the crime scene. After about 10- 15 minutes Dr. Abdur Rehman came back and narrated the discussions taken place with the said police officer, whose name was subsequently conveyed by Dr. Abdur Rehman as "Mr. Khurram Shehzad Waraich" SP, Rawal Town, Rawalpindi. Dr. Abdur Rehman conveyed the orders of Mr. Khurram Shehzad to the staff and they started to wash the crime scene with the help of fire brigade vehicles. It was about 6:40 p.m we washed the scene of crime with the help of two browsers, one belonging to Municipal Fire Brigade driven by "Sufi Nazir Ahmed" Driver and the other was from Rescue-1122. At the time of washing down the crime scene no body from general public was present over there. The people who were the participants of said public gathering / rally had gone to their own destinations and to the respective hospitals either to see and trace their relatives / friends and Mohtarma Benazir Bhutto, who had reportedly died at that time. The police in good quantum was present at the crime scene under the supervision of concerned SHO of City Police Station (name not remember) and under overall command of Mr. Khurram Shehzad Waraich, SP Rawal Town, Rawalpindi. The hosing down of crime scene was done under the specific orders of Mr. Khurram Shehzad, SP Rawal Town, who may be after getting directives / instructions from his seniors on telephone conveyed to Dr. Abdur Rehman, then Emergency Officer, Rescue - 1122.

3. Mr. Walayat Satti who being volunteer of Civil Defence Organization, Rawalpindi was also present on the crime scene alongwith his other staff. According to my memory the staff from Bomb Disposal Squad, Rawalpindi, was very much present there and busy in collecting the relevant material, however, they had left prior to start the washing down the crime scene.
4. It is further stated that some people in plain clothes other than Rescue and Fire Brigade were present and busy in collecting the material / articles, belongs to different secret agencies including army. They were present at the time of washing down the crime scene; however, I can not name any of the people, because I do not recognize them personally.
