## INITIAL INTERROGATION REPORT NOT

Syed Aitezaz Shah @ Saifullah s/o Syed Zaheer Ahmad Shah, Cast Syed, resident of Village Sangal Kot, Post Office & Police Station Battal, Tehsil & District Mansehra.

I was born on 17-02-1992 in Metro Wheel, Karachi. My father has been working as Machine Master, Cotton Factory, located close to Habib Bank, Karachi for the last 20 years. I did my middle class education from Al-Rafeh, Cambridge School, Metro Wheel, Karachi. Lateron, my father got me admitted in Jamia-tul-Aloom, Karachi, a branch of Madrisa-e-Khulpha-e-Rashideen. Maulana Abdul Razzaq Sikandar was Mohtamim of the Madrissa. After learning Holy Quran by heart, I was got admitted in Madrissa 'Tehfeez-ul-Quran', Goal Market, Nazimabad, Karachi. Imdad Ullah Shah was its Mohtamim.

#### **INSPIRATION FOR JEHAD AND PROCEEDING TO SOUTH WAZIRISTAN**

I was inspired for participation in 'Jehad' on seeing jehad's CDs in the house of my cousin namely Hafiz Ismail Shah. I also used to read 'Ummat Akhbar' through which I came to know that the people go for 'jehad' in Afghanistan through Waziristan. I sought permission for 'jehad' from my mother but she refused.

Ehsan Ullah aged 20 years and his nephew Ameer Ullah aged 16/17 years, residents of the area of Makeen (South Waziristan) used to study with me in the Madrissa. Firstly, I told Ehsan Ullah that I wanted to go to Waziristan but he refused to lead me. Lateron, he spoke to Ameer Ullah, who promised to help me to go for 'jehad'. On 1<sup>st</sup> May 2007, he took me to bus stand Sohrab Goth Karachi, from where I bought a ticket for Spungai Rughzai for Rs.600/-. Ameer Ullah told the driver that I had to go the Taliban Office, Makeen, and that he should board me in a bus bound for Makeen from Spungai Rughzai.

On 2<sup>nd</sup> May 2007 at 07.00 AM, I proceeded to Spungai Rughzai by bus without the permission of my parents. I reached Spungai Rughzai on 3<sup>rd</sup> May 2007 at 10.00 AM. The bus driver handed me over to the driver of a pickup and

asked him to drop me in Taliban Office Makeen. I reached Makeen after 1-1/2 hours. Treating me as a guest, the driver did not charge any thing from me. The driver took me to Taliban Office and introduced me to Sanaullah, Ameer, Taliban Markaz. On his query, I told him that I wanted to participate in 'jehad' after completion of my training. Sana Ullah gave me my code name as 'Saifullah'. After about 5/6 months, Sana Ullah was killed in Afghanistan. On his death one Qari 'Lungra', aged 30/31 years, became Ameer, Taliban Office. His left leg had been severed during Afghan's War.

#### JEHADI TRAINING

Sanaullah told me that 40 days training was in process and that I should participate in that. Accordingly, he sent me, in the hilly area, after 2/3 hours journey. Instructor Ameen Shah, resident of Makeen, was imparting the training. Beside physical training, I learnt handling of different fire arms. There were 40/50 boys with me under training. All of them were Mehsud's Taliban. They also included men aged 30/40 years.

#### ARRIVAL OF UNCLE DURING TRAINING

On reaching Makeen, I telephoned my friend Saifullah s/o Mohsin, owner of Medical Store to know the welfare of my mother. My friend gave the telephone number of Makeen to my parents and as a result my uncle Shabir Shah reached Makeen. He tried to take me back to Karachi but I hid myself some where and did not go with him. My uncle went back alone.

#### **SELECTION FOR AFGHAN'S JEHAD**

On completion of training on 7/8 June, 2007 I came back to Sanaullah's Makeen Office. The next day, I alongwith 50/60 persons were selected for Afghan Jehad. After covering 3 days hilly journey on foot, we reached the area of police station Babrik from where we used to open fire on US's Army Camp. After about 40 days, the US soldiers deserted the camp. We took over the camp. On 20<sup>th</sup> July 2007, I alongwith other friends came back to Sanaullah's office Makeen. In this operation, our 8 friends were killed. This operation was led by Sanaullah.

## BRAIN WASHING FOR 'FIDAI ATTACK'

Maulana Ishaque, Imam of a nearby Mosque used to give lecture on 'Fazail-e-Jehad' in the office of Sanaullah. During lecture, he used to preach that during war 'Hazrat Ameer Hamza' was cut into 70 pieces and that we are not ready to be cut even in a single piece. He further preached that 'Fidai Attack' was the greatest sacrifice for Islam. I was convinced that 'maulvi sahib' was preaching true. Accordingly, after 3/4 days I told Sanaullah that I wanted to conduct 'Fidai Attack'.

## TRANSFERRED TO TALIBAN MARKAZ LADHA

On 25/26 July 2007, Sanaullah gave me a letter in 'Pushto' for Ameer Shamim, Taliban Markaz (Mehsud) Ladha and sent me to Ladha. On reaching there, I handed over the letter to Shamim and expressed my desire that I wanted to conduct 'Fidai Attack'. Shamim nodded and said alright.

## TRANSFERRED TO TALIBAN MARKAZ TANGAI

Shamim, Ameer Taliban, Ladha Markaz, took me to 'Fidai Markaz' Tangai in his vehicle and told Rozadeen, Ameer Markaz Tangai that I have been sent by Sanaullah and that I wanted to commit suicidal attack. 10/12 'Fidai Boys' were also present in the Markaz. They were being trained in driving the vehicle. Rozadeen also trained me in driving vehicle. Rozadeen used to preach that 'Fidai' is a great sacrifice in Islam. Shaheed could take 70 persons in 'Jannat' whereas 'Fidai' could take any number of persons to 'Jannat'. Maulvi Zain-ud-Din @ 'Haqqani @ Chamtoo Maulvi(Alam-e-Din of Madrissa Haqqania Akora Khattack) aged 27/28 years, caste Shamankhel, resident of Ladha, used to visit the 'Markaz' and preach Islam and 'Fazail-e-Jehad' stating that 'Fidai' will get the great reward.

## Description of Zain-ud-Din

Wheatish colour, aged 28/30 years. Height 5-7/8", smart body, blue eyes, red long beard and wears Sindhi Cap.

#### SELECTION FOR FIDAI ATTACK

After about 2-1/2 months in 'Fidai Markaz' Tangai, Rozadeen told me in October 2007 that it was now my turn for 'Fidai Attack'. On query, he told me that I would commit suicidal attack on Benazir. I accepted it saying alright.

#### TRANSFER TO SHERZAMAN'S HOUSE IN SEEGA

On the same day (Noon), Wali Muhammad @ Umri, Ammer of Markaz Dhela, visited 'Fidai Markaz' Tangai and took me to the house of Sherzaman (another arrested suspect) in Seega, in a vehicle. His house is located at a distance of 4/5 minutes journey on foot. Amjad aged 17/18 years, resident of Swabi and Sabir (Mehsud), resident of Kotkai (South Waziristan) were already present in the Markaz. They were brought there earlier to me by Wali Muhammad from Dhela Markaz. In addition, Sherzaman and his nephew Ikramullah aged 17/18 years were also present there. I saw Ikramullah several times in the company of Shamim, Ameer, Taliban Markaz, Ladha. Amjad and Sabir were also brought there for the commission of suicidal attack on Benazir alongwith me. After taking lunch, Wali Muhammad went back whereas Sherzaman went to his house. On query, Ikramullah told me that I had to go to Karachi for suicidal attack on Benazir. Sherzaman left for some place in the next morning and did not come back. As such I could not discuss with him about 'Fidai Attack' on Benazir.

#### PREPARATION OF FIDAI ATTACK AND CANCELLATION OF PROGRAMME

On one night, after living for 5/6 days in the house of Sherzaman, Ikramullah told that I and others would leave for 'Fidai Attack' in the morning. Accordingly, we all three got up in the morning, took bath and started the preparations. Meanwhile, Ikramullah received telephone call from Wali Muhammad and intimated us that the programme had been cancelled. Accordingly, we all proceeded to Dhalay to see Wali Muhammad. On reaching there, Wali Muhammad told us that their two men had been arrested by Peshawar Police and as such they could not go forward. It was because of this reason that the programme had been cancelled. I stayed back with Wali Muhammad. Amjad and Sabir went to Kotkai whereas Ikramullah went back.

#### STAY IN 'FIDAI MARKAZ' DHALAY

I started living with Wali Muhammad in 'Fidai Markaz' Dhelay where 25/30 boys were also present, 8/9 boys were of the age of 10 to 15 years, whereas 14/15 boys were of the age of 15 to 22 years. All these boys were ready for 'Fidai Attack'. I lived in this camp from the middle of October to 16<sup>th</sup> January, 2007 – for about 3-1/2 months. Every person who had to commit 'Fidai Attack' had to live in this 'Markaz' because he had to take commitment from his colleagues that they would not commit 'Ghadari' against his blood. The 'Fidai Attackers' always tried to take lead over others. Every body wanted that he should go for 'Fidai Attack' first of all. Mufti Tariq r/o Sara Rogha used to preach the boys and while explaining 'Fazail-e-Jehad', it used to be told that 'Shaheed' was of four kinds:-

- i. 'Ajiz Insan' who has committed no 'Gunah' (first).
- ii. There are 'Gunah' but 'Sawab Ke Kam' are more(Second)
- iii. 'Gunah' and 'Sawab' are equal (Third)
- iv. 'Gunah' are more than 'Sawab' (Fourth)

It used to be preached that 'Fidai Shaheed' will get 72 'Hoors' in 'Jannat'.

(Despite questioned repeatedly, Aitezaz Shah is sticking to his version that except Amjad r/o Sawabi and Waheedullah r/o Naushehra/Mardan, all the boys were local Mehsud. No one belongs to other area).

### UMER, AN ACTIVE 'FIDAI' OF DHALAY MARKAZ

Shahmaal @ Umer r/o Khadey Karma is an active member of Dhalay Markaz of Wali Muhammad. He keeps all secrets of the entire network. He is with them since the start of 'Fidai Attacks'. He himself disclosed that he has been with 'Fidaeen' for the last about 2-1/2 years. About 85 'Fidaeen' have accomplished their assignments in Afghanistan and Pakistan successfully. He himself went for 'Fidai Attacks' for 13 times but his turn did not come and as a result he came back. He goes out of Waziristan to certain places including Karachi. He is the right hand of Qari Hussain. If he is arrested, all information relating to 'Fidai' proceedings can be extracted from him. He is matriculate and speaks Pushto, Urdu, Persian and English. He married but deserted his wife. He is called Umer in the Markaz. Umer told him that Khanadin r/o Dhalay committed suicidal attack on a vehicle in Kohat whereas Sajjad r/o Baroond committed suicidal attack in Jandola. He has no other details about Fidai Attacks. On 10/11 January, 2008, Umer brought 3 boys to Dhalay Markaz from Kawari Colony, Karachi:-

- 1. Zahid whose father is Tableeghi and drives Mazda.
- 2. Adnan whose father is in Dubai.
- 3. Does not remember the name of third boy.

# DESCRIPTION OF SHAHMAAL @ UMER R/O KHADEY KURMA, LOCATED AT A DISTANCE OF ½ HOURS FROM FIDAI MARKAZ DHALAY.

Age 21/22 years, Height 5-2/3", body smart. Limps while walking. Big black eyes. Wear Sindhi Cap.

### 'FIDAI-ATTACK' ON BENAZIR IN KARACHI

During the stay in Dhalay Markaz, Umer disclosed that Baitullah Mehsud men attacked Benazir in Karachi. The person driving the vehicle was untrained. He blasted the vehicle before reaching close to Benazir's vehicle. The second boy of 'Jacketwala' also exploded far from the target.

#### MEETING WITH QARI HUSSAIN, NAIB COMMANDER BAITULLAH MEHSUD

One day he went to the bazaar of Spungkai Rughzai alongwith Wali Muhammad where he met Qari Hussain who was Ameer Markaz Dhaley earliear to Wali Muhammad. I shook hand with him and did not indulge in any conversation with him. The 'Fidaeen' of Dhalay Markaz used to say that Qari Hussain was better Ameer than Wali Muhammad. Qari Hussain had been sent to Kuram Agency by Baitullah Mehsud for other assignment. Some 'Fidaeen' also said that Qari Hussain wanted to form his own group. In any case, his transfer from Dhalay Markaz was the 'Siasat' of Baitullah Mehsud. Qari Hussain had left the Markaz about 2/3 months of my arrival.

#### **MOTIVE FOR LAUNCHING FIDAI ATTACK ON BENAZIR**

Wali Muhammad used to say that Benazir had been sent by USA on a special assignment. She is against Taliban and that she would launch operation against them in Waziristan. Secondly, the election/selection of woman is not Islamic as per 'Shariat'. It was because of these reasons that they planned to kill Benazir by launching 'Fidai Attack'.

#### MEETINGS WITH BAITULLAH MEHSUD

He met Baitullah Mehsud as per following detail:-

#### First Meeting

Baitullah Mehsud visited some body in Dhalay. Wali Muhammad, Ameer 'Fidai Markaz' Dhalay took me and 2/3 other boys to see him. We met Baitullah Mehsud. He knew earlier that I would commit 'Fidai'. I was happy to see the senior most commander. He asked me as to which place I belonged. I gave him the complete detail. He said all right. Lateron, he talked to Wali Muhammad separately and then went away.

#### **Second Meeting**

Alamgir r/o Gurai (Area of Dhalay) aged 17/18 years was going to participate war in Kurram Agency. Wali Muhammad took me to the house

of some one in Makeen to see Baitullah Mehsud. I met Baitullah Mehsud who inquired about my welfare.

#### JOURNEY TO LADHAY MARKAZ AND MEETING WITH SHERZAMAN

On 21.12.2007 (Eid-ul-Azha day) I went to Taliban Markaz Ladhay to see my friends with the permission of Wali Muhammad. I stayed in 'Markaz' for one night, the other night in the house of Sajjad, located in Shamzai Ladha and the third night with Shamim in the house of his friend. On 24.12.2007, he met Sherzaman in the bazaar of Ladha. I told him that I would stay with him for a night. He visited the 'Markaz' with me. I went with him with the permission of Shamim, Ameer of the 'Markaz'. He had already a guest in his house and as such we could not talk about. Sherzaman did not tell me any thing about his guest. However, he introduced me to the guest as Mechanic having an amount of Rs.15/16 Lacs for establishing a shop here.

#### DISCLOSURE OF SHERZAMAN REGARDING 'FIDAI ATTACK' ON BENAZIR

On the next day i.e. 25.12.2007, I inquired from Sherzaman as to why I was not being sent for 'Fidai Attack'. Sherzaman told me that Baitullah Mehsud had given an amount of Rs.50 thousands to some person for providing 'Samaan' for killing Benazir. That person did not provide the 'Samaan' and as such they got late. Now the person had provided the 'Samaan' and that they would send me after ¾ days. Sherzaman further told that that they wanted to do such an act which could hit the target only and no harm was caused to the public and that the 'Ameer Sahib' would appreciate this. Lateron, Sherzaman said that they were going to Dera Ismail Khan and that I would get his telephone number from Wali Muhammad and call him to morrow at 1.00 PM. Lateron, I came back to Dhalay Markaz.

#### THIRD MEETING WITH BAITULLAH MEHSUD

On 26.12.2007, I went to the bazaar of Spungai Rugzai alongwith Wali Muhammad. It was planned that we would talk to Sherzaman on phone after 1.00 PM. Wali Muhammad went into a shop for hair cut. I was rolling about on the road of Spungai Rugzai when all of sudden a vehicle reached there wherein

Baitullah Mehsud was sitting. On seeing me, he stopped the vehicle and asked me as to why he had not left for the task. I replied that I would leave when permitted by Sherzaman. Upon this Baitullah Mehsud shook hand with me saying that they would meet in 'Jannat' and left.

## **CONTACT WITH SHERZAMAN ON TELEPHONE & PREPARATION FOR FIDAL**

After hair-cut, Wali Muhammad gave me the telephone number of Sherzaman written on a chit. I contacted Sherzaman and spoke to him. I inquired about my departure who told that he would send a man after about 2/3 days. Meanwhile, Wali Muhammad took telephone from me and spoke to Sherzaman in Pushto. Wali Muhammad told me that Sherzaman would send a person to Dhalay within 2/3 days and that we would proceed with him for Fidai. He did not disclose the destination. I also joined Wali Muhammad at Dhalay Markaz after my hair cut and started waiting for the departure time alongwith Amjad and Sabir.

#### **INFORMATION OF FIDAL ATTACK ON BENAZIR**

On 27.12.2007, we came to know on radio (BBC) that Benazir has been killed in 'Fidai Attack'. The boys present in the camp congratulated each other. Wali Muhammad was not present at the 'Markaz' at that time. He came in the 'Markaz' the next day and congratulated the boys. I was angry as to why I had not been sent for Fidai Attack on Benazir. It was because of this reason that I did not speak to Wali Muhammad.

## WALI MUHAMMAD'S VERSION ABOUT 'FIDAI ATTACK' ON BENAZIR

Wali Muhammad visited Dhalay Markaz after about 4/5 days. I asked him as to what was the reason. In-fact we had been selected for the task but some body else had been dispatched for the same. Wali Muhammad told that these boys belong to Baroond Markaz. One of them was Bilal and the other was Ikram. Ikram had come back unhurt to whom he met. Ikram told him that he fired three shots on Benazir and then Bilal conducted the blast. He fell far away due to the blast. When he got up he found himself unhurt. Upon this he threw his jacket and came back. Bilal is resident of Baroond and Ikram is of Makeen. I have not seen them ever. Maulvi Azal Ullah is the Ameer of Baroond Markaz. His real name is

maulvi Aziz Ullah. Meanwhile Wali Muhammad told us that they had to go for the attack at a place where Benazir had to conduct her last Jalsa. He did not disclose the place. Had she survived in this attack, they would have gone for the same mission.

#### MARAKIZ OF FIDAEEN IN WAZIRISTAN

The following three 'Marakiz' are working in South Waziristan:-

- i. Tangai, South Waziristan (Ameer Rozadeen).
- ii. Dhalay Khas, South Waziristan (Ameer Wali Muhammad @ Umri)
- iii. Baroond, South Waziristan (Ameer Aziz Ullah Maulvi @ Azal Ullah.

  Fourth Markraz is located in Mir Insha (North Waziristan). His Ameer is Khalifa.

#### FOURTH MEETING WITH BAITULLAH MEHSUD

About 8/10 days after the death of Benazir, I alongwith Wali Muhammad and Ishaque r/o Kotkai went to Saro Rogha on 7/8 Jan: 2008 where I met Ameer Baitullah Mehsud. I told him that on one hand I was told to be ready for Fidai Attack but on the other hand some body else was launched from the attack. Upon this, Ameer Baitullah Mehsud replied that it was matter of luck and that when my turn would come I would go. This time Wali Muhammad told Baitullah Mehsud that I would be sent to Karachi and that there was a Hotel, wherein the Americans stay. Baitullah said all right.

## DEPARTURE FOR 'FIDAI ATTACK' FOR THE THIRD TIME

On 16.01.2008, I was present in Dhalay Markaz. Wali Muhammad came there and asked me to get ready as his turn had come. I had already taken bath in the morning. I took my meals and requested the colleague-boys to forgive him his faults. We proceeded to Taliban Markaz Umer Rugzai with Wali Muhammad. Wali Muhammad had given me an amount of Rs.11 thousands. Wali Muhammad told him to reach Dera Ghazi Khan from where I would contact Sherzaman on a telephone number written on a chit. Sherzaman would give me 'Samaan' and also

the target. Wali Muhammad had indicated a hotel in tower, Karachi wherein the Americans stay.

### JOURNEY FROM UMER RUGHZAI TO MIRAN SHAH

A vehicle carrying Taliban was bound for Miran Shah after 'Zohar Prayers'. Israr, Islam and Esa Talibans and Nazir r/o Pizu Distt. Tank and Ali Khan Afghani were also traveling in the same vehicle. Wali Muhammad told Nazir and Ali Afghan that they would take care of me during journey. We reached Miran Shah on the next morning i.e. 17.01.2008 at 10/11.00 AM. After taking meals we went to Bannu where Ali Afghani left for Peshawar. I and Nazir started for DI Khan. During journey Nazir disclosed that he and Ali Afghani loot American Containers and big banks and give funds to Baitullah Mehsud. He also disclosed that he is on contact with maulvi Faiz Ullah r/o Makeen, right hand of Baitullah Mehsud, who lives in Sohrab Goth Karachi. I also contacted Sherzaman at Bannu. We reached village Pezo at 'Asar time' where Nazir left him. I contacted Sherzaman through a mobile phone of a shopkeeper and he told me to contact him on reaching Sabzi Mandi DI Khan through some PCO. Nazir had asked me that in case Sherzaman did not meet him then contact Faisal on his mobile phone No.0300-9345813. Who would inform him and then I should join him.

#### CONTACT WITH SHERZAMAN ON REACHING D.I. KHAN

It was almost dark when I reached 'Sabzi Mandi' DI Khan. All PCOs had been closed. I contacted Sherzaman through mobile phone taken from the shop of a Photostat Machine, located closed to Rehman Hospital Chowk and told him that I was standing near Rehmania Hotel. Sherzaman asked me to reach near graveyard on Multan Road.

#### **ARREST**

I reached the graveyard Multan Road, DI Khan on a vehicle. I came out of the vehicle and started waiting Sherzaman. Meanwhile, a police man came to him from the nearby shop and started questioning me and the driver. I told him that I had come to see my uncle Sherzaman. Meanwhile, two other police men reached there who tried to search me to which I resisted. Upon this one of the police man

slapped me and searched me. The following articles were recovered from my pocket which made them certain that I was 'Fidai':-

- i. A small Mirror on which 'Fidayan' was written.
- ii. The chit on which Wali Muhammad had written the telephone number of Sherzaman was a chit written by Naib Ameer Yousaf of Ladha Markaz to Ameer Wali Muhammad, Dhalay Fidai Markaz. In this chit it was written that father of a Fidai wanted to see him and if he was available in Markaz he be allowed to see him.
- iii. Wali Muhammad, Ameer dhala Markaz asked me to write the names of all Fidayan. I wrote the names of Fidayan on both of this chit.

SP Sahib and the driver took me to his office and interrogated me. I withdrew from my previous statement. Upon this, he called another officer and it was during his interrogation that I spoke the truth to the effect that I was Fidai and that I was member of a team earlier tasked for launching Fidai Attack on Benazir.
